

Visas

There are many nationalities which do not need any entry visa for Serbia, or permits for stay of up to 90 days. Please see the following page to check whether entry visa for Serbia is required for your citizenship:

As a foreign student, you will need to obtain your temporary stay visa for legal stay in the Republic of Serbia during your exchange (one semester or more). Accommodation

The two most common types of accommodation used by foreign students and visitors to the University of Belgrade are renting a room at the Students' Centre Belgrade (student dormitory or one of their two hostels), or renting private housing. Rental of studio may range from EUR 150 to EUR 350 per month.

Local time

Belgrade and Serbia are located in the Central European time zone region – GMT +1 and/or GMT +2 as of the last week in the third month until the Saturday prior to the last week of the tenth month.

Local currency

The official currency in Serbia is dinar, abbreviated RSD. Money may be exchanged in all banks and post offices, as well as in authorized exchange offices.

F. M. Dostoevsky Omsk State University, Russia

I came to study at the University of Belgrade in the spring semester 2016/17. It was a pleasure for me to get to know many people from different countries in Belgrade by the Erasmus Student's Network. There were only a few exchange students at the Faculty of Economics during my semester, but that did not matter to me. I was lucky that the faculty offered similar courses like those I would have attended in Germany and the results of the exams were counted at my home university.
